In the event this indemnification is terminated by either you or us, your obligation to hold harmless, defend and indemnify shall survive for such property use allowed you by Midsummerfest prior to the termination of this indemnification agreement. In the event this indemnification is terminated by either you or us, your obligation to hold harmless, defend and indemnify shall survive for such products lent to you by Midsummerfest prior to the termination of this indemnification agreement. This indemnification agreement is in addition to any claim for indemnification or contribution which Midsummerfest may have against you in law, at equity, or otherwise.
